IN RULING ON PRE-TRIAL DISCOVERY MOTIONS IN THE CASE "UNITED STATES V. TIMOTHY JAMES MCVEIGH (CASE NO. 96-CR-68-M), THE UNITED STATES DISTRICT COURT HAS THUS FAR ORDERED THE GOVERNMENT TO DISCLOSE TO THE DEFENSE WHETHER TWO INDIVIDUALS HAVE EVER SERVED THE GOVERNMENT AS CONFIDENTIAL SOURCES, ASSETS OR COOPERATING WITNESSES. THESE TWO PERSONS ARE [REDACTED] AND [REDACTED]

IN REFERENCED [REDACTED] TELEPHONE CONVERSATION AND [REDACTED] CIA TELETYPE, [REDACTED] PROVIDED THE RESULTS OF THE NAME TRACE ON [REDACTED]

AS DISCUSSED IN REFERENCED [REDACTED] TELEPHONE CONVERSATION, SSA [REDACTED] HAS NOW BEEN TASKED TO CONDUCT THE SAME INQUIRY TO SEVERAL U.S GOVERNMENT AGENCIES CONCERNING [REDACTED]. THE DEFENSE IS ALLEGING THAT [REDACTED] IS A "CONFIDENTIAL GOVERNMENT SOURCE", AND IS A COCONSPIRATOR IN THE BOMBING OF THE ALFRED P. MURRAH FEDERAL BUILDING IN OKLAHOMA CITY. INVESTIGATION TO DATE HAS DISCLOSED NO INFORMATION TO SUBSTANTIATE THE DEFENSE'S ALLEGATIONS.

IN VIEW OF THE ABOVE, THIS INQUIRY CONCERNS [REDACTED] AND WHETHER HE HAS EVER BEEN A CIA CONFIDENTIAL SOURCE OR ASSET. HE IS BELIEVED TO BE CURRENTLY LIVING IN GERMANY.

THE BOOK WAS USED AS A MODEL FOR AN ACTUAL WHITE SUPREMACIST ORGANIZATION BY THE SAME NAME. IN 1983, THE ORDER (OR BRUDERS SCHWEIGEN) WAS FORMED IN WASHINGTON AND IDAHO. MEMBERS OF THE GROUP COMMITTED MURDERS, ARMED ROBBERIES OF ARMORED CARS AND BANKS, AND ENGAGED IN COUNTERFEITING IN SUPPORT OF THEIR ORGANIZATION. APPROXIMATELY 40 MEMBERS OF THE ORDER WERE EVENTUALLY ARRESTED AND THE GROUP HAS NOT BEEN ACTIVE IN ALMOST A DECADE.

THE FBI POSSESSES NO INFORMATION THAT ANY RIGHT WING EXTREMIST GROUPS ARE CURRENTLY PLANNING ACTS OF VIOLENCE IN RETALIATION FOR U.S. GOVERNMENT EFFORTS IN THIS INVESTIGATION. HOWEVER, ALTHOUGH "THE TURNER DIARIES" SPECIFICALLY TARGETS FBI HEADQUARTERS, THE FOCUS OF THE WHITE SUPREMACY MOVEMENT IS ON THE ENTIRE FEDERAL GOVERNMENT. THEREFORE, ALL RECIPIENTS ARE BEING MADE AWARE OF THE ABOVE INFORMATION. MOREOVER, THE LAST FEW DAYS OF INTENSE LAW ENFORCEMENT ACTIONS UNDERTAKEN BY THE UNITED

HOWEVER, ALTHOUGH "THE TURNER DIARIES" SPECIFICALLY TARGETS FBI HEADQUARTERS, THE FOCUS OF THE WHITE SUPREMACY MOVEMENT IS ON THE ENTIRE FEDERAL GOVERNMENT. THEREFORE, ALL RECIPIENTS ARE BEING MADE AWARE OF THE ABOVE INFORMATION. MOREOVER, THE LAST FEW DAYS OF INTENSE LAW ENFORCEMENT ACTIONS UNDERTAKEN BY THE UNITED

HOWEVER, IN THE WAKE OF THE 4/19/95 BOMBING, THE FBI AND OTHER FEDERAL LAW ENFORCEMENT AGENCIES HAVE RECEIVED NUMEROUS BOMB THREATS AGAINST FEDERAL GOVERNMENT FACILITIES AND THREATS OF PHYSICAL VIOLENCE AGAINST GOVERNMENT OFFICIALS. WHILE THE MAJORITY OF THESE THREATS ARE HOAXES, THE INCREASED VOLUME OF THREATS IS OF CONCERN. THEREFORE, THE FBI RECOMMENDS CONTINUED HEIGHTENED SECURITY AT ALL FEDERAL FACILITIES IN THE UNITED STATES FOR ANOTHER 30 DAYS.

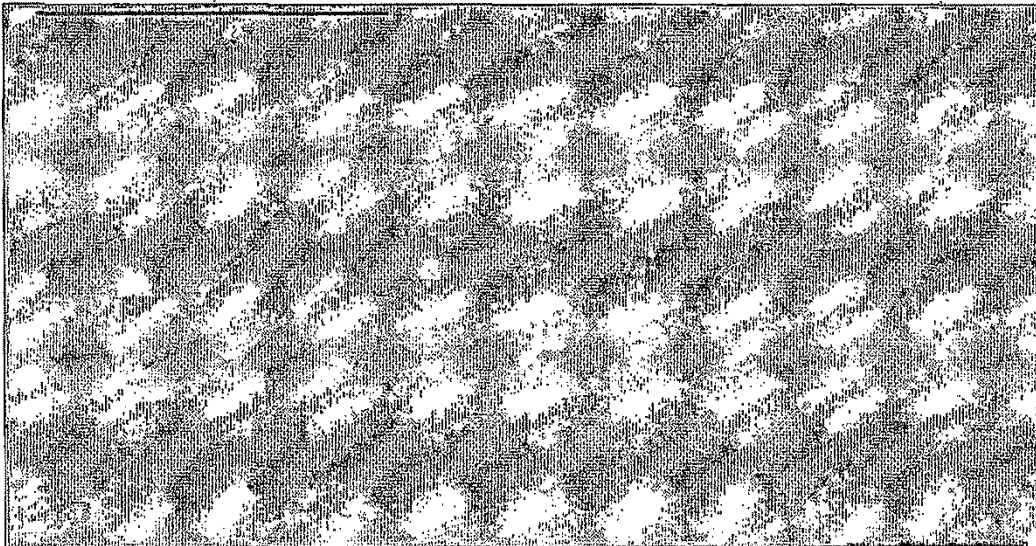

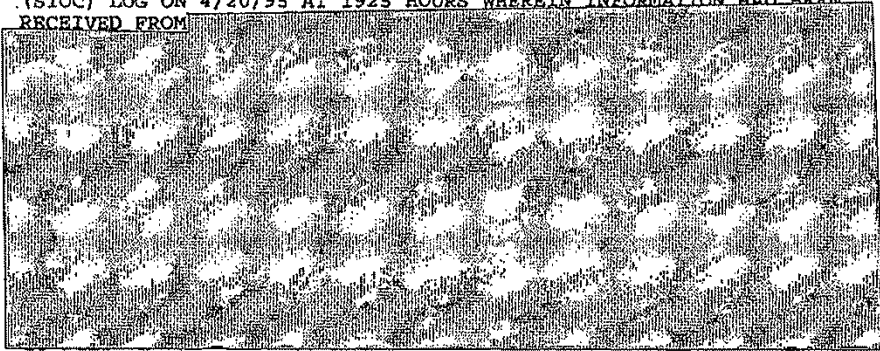

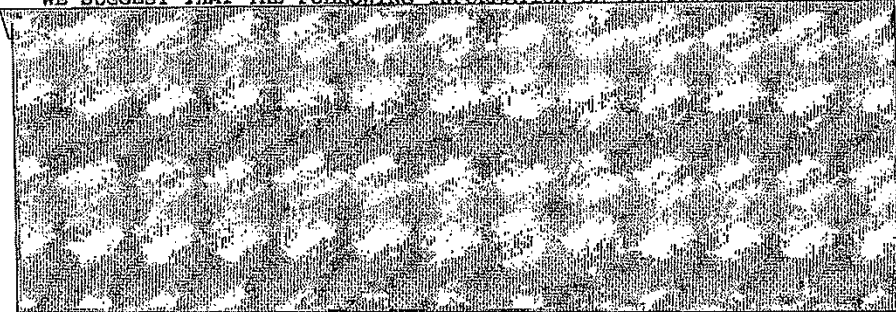
