**PRIVACY WAIVER RE: ANDREAS

Pursuant to 28 U.S.C. §1746 I, Andreas Carl Strassmeir, declare as follows:

1. I was born in Berlin, Germany on May 17, 1959, and currently reside in the German National Republic.

2. At the time of the bombing of the Alfred P. Murrah Building, I was residing at Elohim City, near Muldrow, Oklahoma.

3. I am aware that many people, including members of the press and television media believe or suspect, because of my presence at Elohim City, that I was an informant and/or agent working on behalf of the government of the United States of America and/ or some agency thereof, the Southern Poverty Law Center and/or some foreign government or a combination these entities.

4. I am also aware that Jesse C. Trentadue is, pursuant to the *Freedom of Information Act*, 5 U.S.C. §§552 *et. seq.*, attempting to obtain records/documents from the United States government related to my presence at Elohim City and the possibility that I was an informant and/or agent for the United States government, the Southern Poverty Law Center and/or another entity.

5. I am aware, too, that under the *Freedom of Information Act* any records/documents which the United States government has created, gathered, compiled, obtained or possesses concerning me and my activities while at Elohim City may be exempt from disclosure to Jesse C. Trentadue under various privacy provisions, including 5 U.S.C. §552(b)(5),(6) and (7).

6. I deny that I was ever an informant/agent of the United States government,

the Southern Poverty Law Center and/or any other entity, foreign or domestic.

7. Consequently, it is my intention by this declaration to waive and I hereby do waive any and all *Freedom of Information Act* privacy exemptions, including but not limited to those set forth at 5 U.S.C. §552(b)(5, (6) and (7), that might otherwise deny Jesse C. Trentadue access to the records/documents which the government of the United States has compiled, gathered, obtained, created and/or possesses on me and/or my activities at Elohim City, including any association I may have had with Timothy McVeigh, the bombing of the Murrah Building or as an informant and/or agent..

8. I do, therefore, state, certify, verify and declare that this document, including a copy thereof, authorizes Jesse C. Trentadue to obtain and the government of the United States and all of its agencies, bureaus and subdivisions, including but not limited to the Department of Justice, Department of State, Department of the Treasury, Central Intelligence Agency, Department of Defense, Department of Commerce, Department of Homeland Security, Federal Bureau of Investigation, Bureau of Alcohol Tobacco and Firearms, Secret Service, and/or Bureau of Immigration and Customs Enforcement to release to Jesse C. Trentadue any and all records/documents it or its agencies or subdivisions have compiled, gathered, created, obtained and/or possesses concerning me and/or my activities at Elohim City, including any records/documents,

directly or indirectly, related to any association I may have had with Timothy McVeigh, the bombing of the Murrah Building or as an informant and/or agent.

9. I further state, declare, verify and certify under penalty of perjury under the laws of the United States of America that that I am, Andreas Carl Strassmier, the person named above and that the foregoing is true and correct.
